The former FG Barnes MG/Vauxhall Vehicle Dealership is primely situated on the corner of the A274, Sutton Road, and Bircholt Road on Maidstone Industrial Estate. The surrounding area has a mixture of main car dealerships including Mercedes, Citroen, Mazda, Nissan, Hyundai and Motorpoint plus a series of Industrial national and local occupiers.

The site is the most prominent on the estate and as well as motor trade use would suit a variety of commercial or retail occupiers, subject to obtaining the necessary planning consent.

The main showroom building at the front of the state has been designed to incorporate two vehicle franchises but could be re-fitted for a single occupancy user. On the ground floor it has showroom and sales areas plus valeting bay and sales offices plus ladies and gents wcs. The first floor has been used as offices and is primarily open plan with some smaller meeting rooms and kitchen. The property benefits from Air Conditioning, Suspended Ceiling with LED Lighting and electric storage heaters. The property has been measured on a Gross Internal Area (GIA) basis as follows:

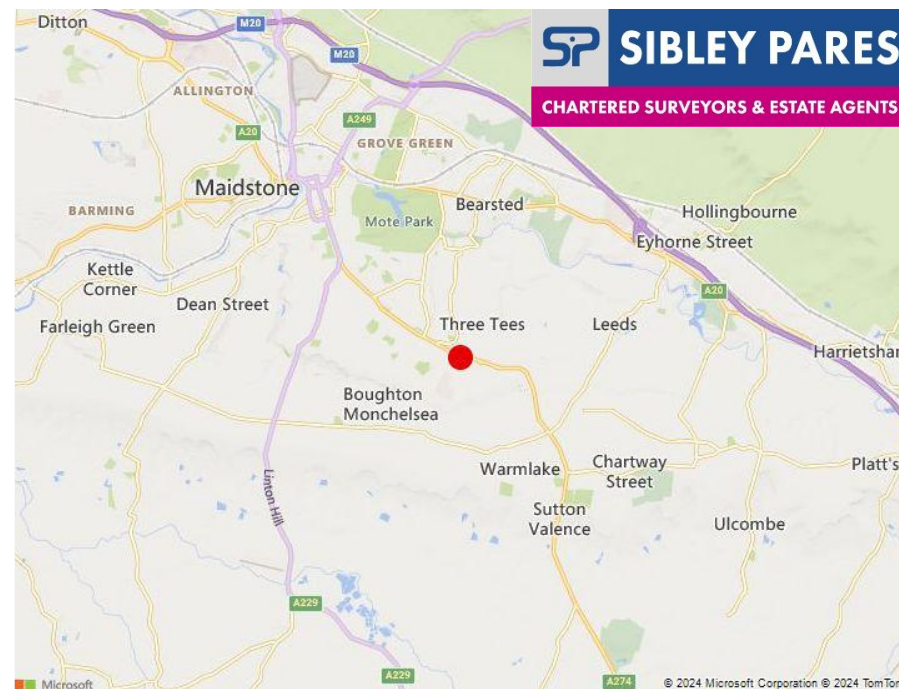
