DESCRIPTION

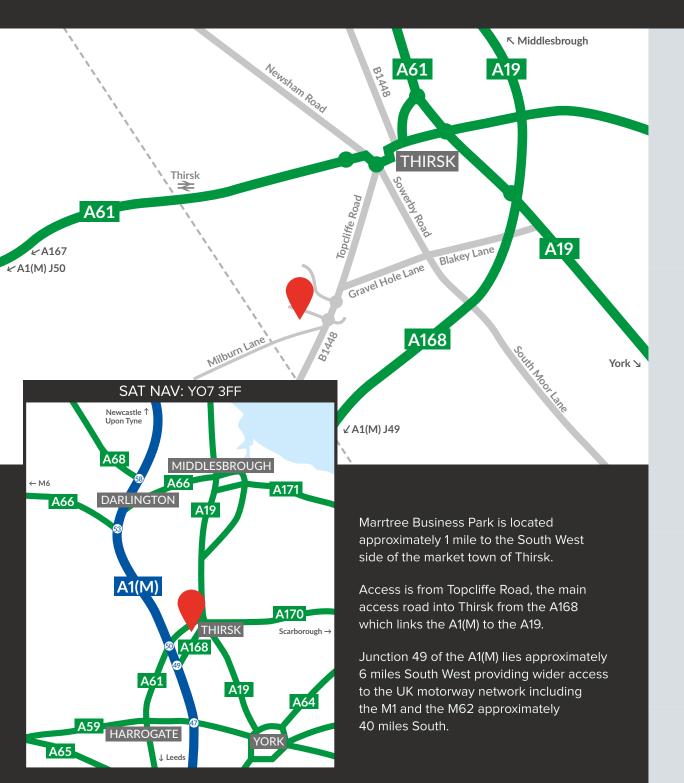
