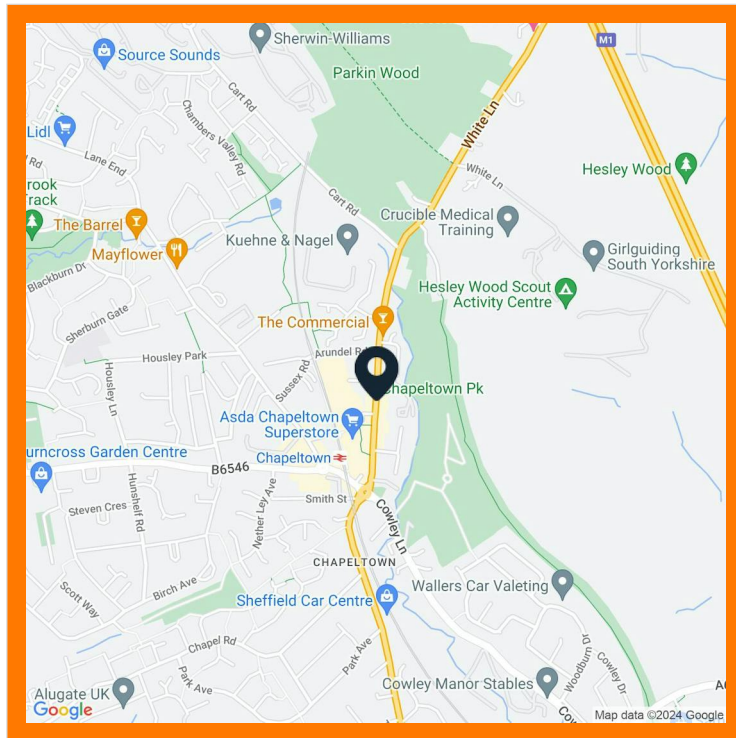

The premises is arranged over two floors. The ground floor consists of the former banking hall and meeting rooms, with ancillary staff accommodation and WC's on the first floor.

Location

The property fronts onto Station Road in the centre of Chapeltown in South Yorkshire, backing onto the Asda supermarket, and directly adjoining a pet supplies store. Chapeltown is northern suburb of Sheffield, approximately 7 miles from Sheffield city centre and 9 miles south of Barnsley town centre. Chapeltown train station is a short walk away providing services to Huddersfield and Sheffield. There is a bus stop directly outside the property.

Planning

The premises are understood to have an Class E consent.

This allows the premises to be used for the former A1 (retail), A2 (financial and professional), A3 (restaurant), B1 (offices), and D1 (clinics, health centre and day nursery) uses, without the need for a change of use.
