## LOCATION

The Courtyard is situated in a prime position on the corner of St George's Road and Francis Grove. Wimbledon's strategic location and excellent transport links have ensured its continuing success as of London's decentralised office locations.

The Centre Court Shopping Centre and Crescent have attracted many major national retailers and a wide selection of entertainment and leisure facilities to Wimbledon Town Centre. ## DESCRIPTION

Prominently located in the heart of Wimbledon Town Centre, The Courtyard is a five-storey office building, with imposing front elevations. The property benefits from vaulted ceilings, excellent natural light and two balconies which offer far reaching panoramic views. Car parking is available on site at a ratio of 1 space per 1,000 sq ft occupied. There is an additional charge of £1,500 per space per annum which increases annually in line with RPI. The property has undergone a full refurbishment.

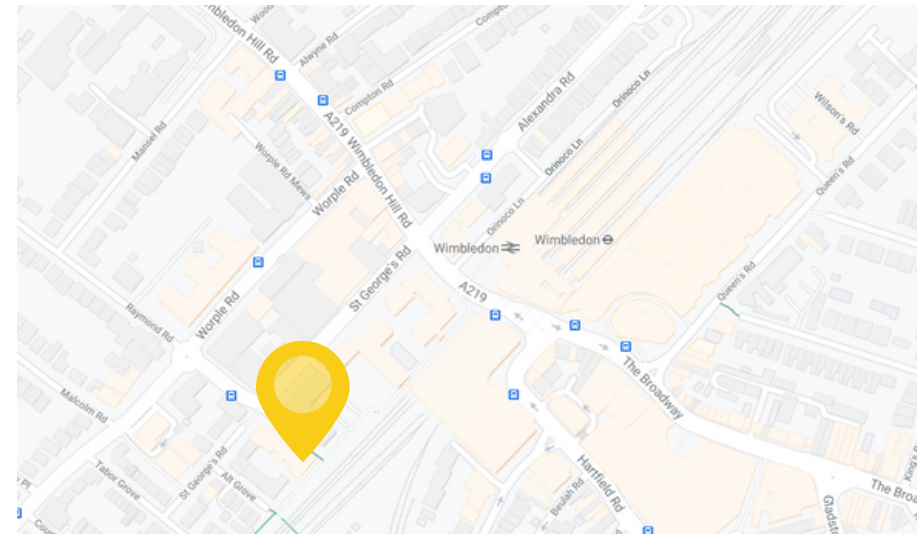
