## LOCATION

The subjects are positioned on the south side of Dorchester Avenue, occupying a relatively central location at the boundary of Anniesland and Kelvindale areas of Glasgow.

Glasgow City Centre lies approximately 4 miles to the East. Anniesland is a highly desirable residential area in the West End of Glasgow, with the popular Kelvinside and Hyndland areas located nearby.

There are excellent transport links to Glasgow City Centre with regular bus routes. Kelvindale Train Station is within 0.5 miles. Dorchester Avenue meets its junction with Great Western Road leading to Glasgow City Centre and the M8

Motorway. Commercial occupiers in the immediate vicinity are of a local independent nature, these include Jaipur Balti House, Ocean Park Takeaway, About Hair and Beauty and Spar.


## PROPERTY
