Location

The property is situated towards the northern end of New Hythe Lane in Larkfield, within New Hythe Business Park and is surrounded by a range of established commercial occupiers.

New Hythe railway station lies within approximately 200 metres of the property, which also benefits from excellent transport links, being around 2km from Junction 4 of the M20.

Accommodation

The accommodation comprises the entire east wing of a modern, purpose-built office building. The layout is predominantly open plan, complemented by a range of private offices, meeting rooms, ancillary areas, and a dedicated gym. A mezzanine level provides a boardroom and separate kitchen facilities, offering a self-contained executive space.

Access is via the central lobby, where a manned reception can be provided if required. In addition, a large roller shutter door allows direct vehicular access to a secure storage area, ideal for deliveries and loading.

Externally, there are in excess of 70 car parking spaces, along with designated turning and loading areas, contained within secure landscaped grounds.
