Silver Court is situated on Intercity Way in Pudsey, approximately 200 yards from Swinnow Lane. Swinnow Lane in turn provides access onto the A647 Stanningley By-Pass, one of the major routes between Leeds and Bradford City Centres. The estate is located 0.5 miles from Pudsey Town Centre and the Owlcotes Shopping Centre. The units are superbly located for all local and regional amenities.

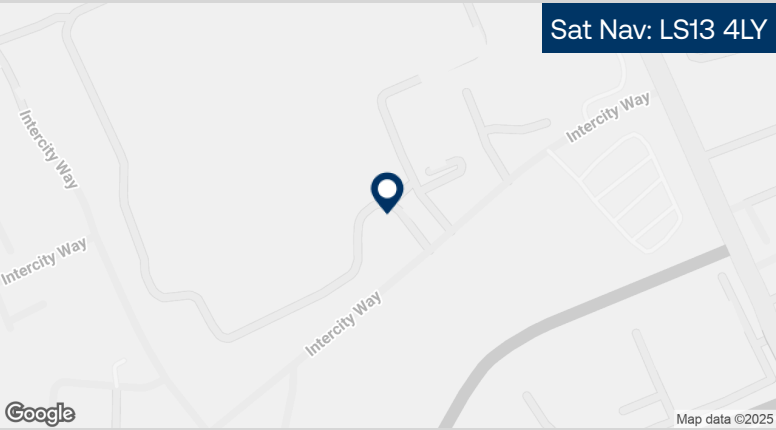
