Location

The property is located at the entrance to Bowburn North Industrial Estate. Bowburn is situated approximately 4 miles south of Durham and 17 miles north of Darlington at J61 A1(M). Access to the estate is off the A177.

Bowburn North is a well-established estate, with several manufacturing, logistics and trade counter occupiers in situ, including Electrolux, Esh Group and Brakes. The estate is located immediately north of Amazon's 2m sqft Durham fulfilment centre.

Proposed Refurbishment

- New dedicated entrance for the unit to be created from estate road.
- New office windows and redecoration of cladding to the front elevation.
- Internal warehouse clearance and redecoration.
- Internal office refurbishment.

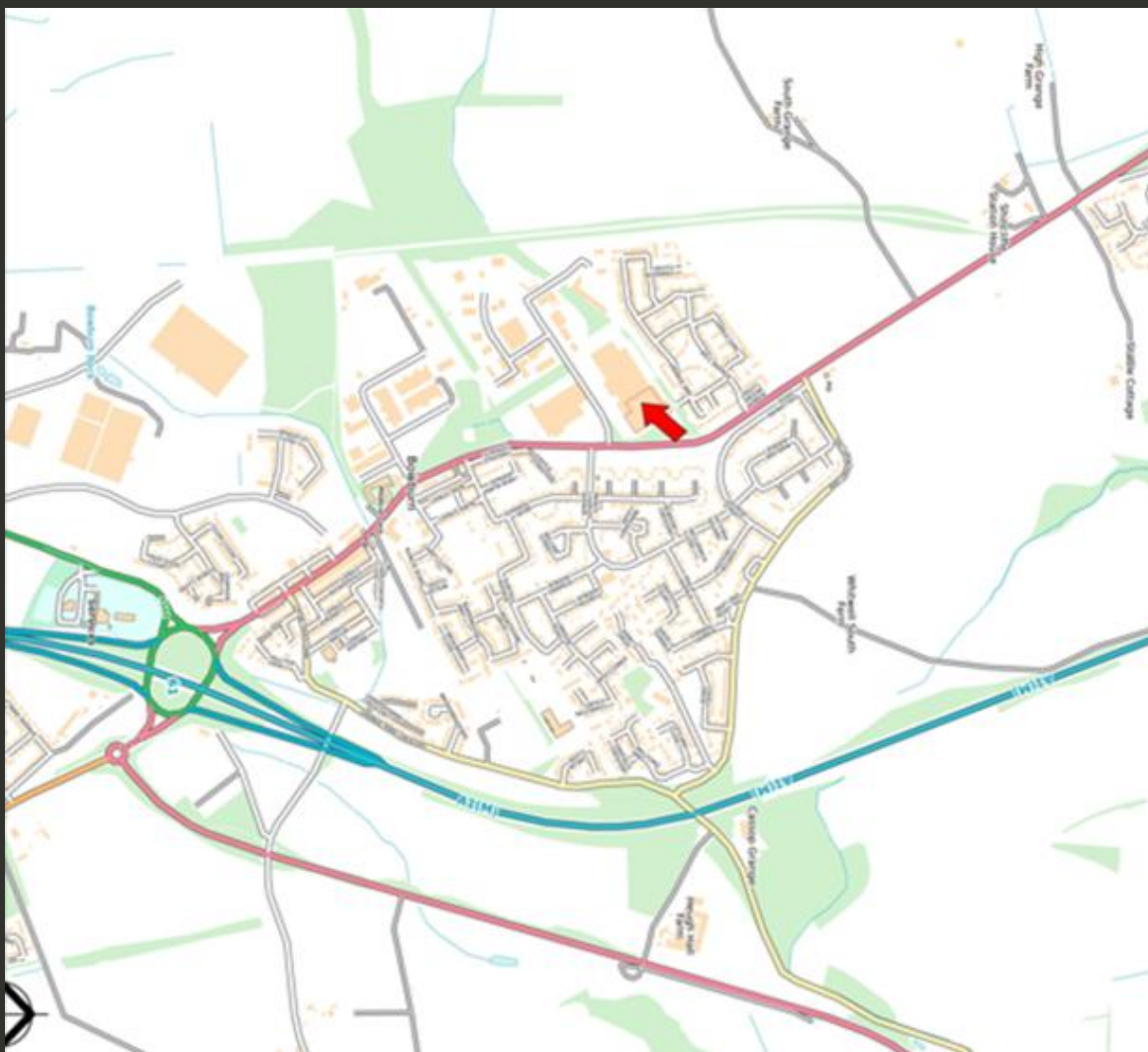
