Location:

The properties are situated in the Aston area of Birmingham just off the B4144 Walter Street which in turn provides access to the A5127 Lichfield Road. Birmingham City Centre is located approximately 2 miles to the south-west of the property.

Junction 6 of the M6 Motorway is approximately 1 mile distant in turn linking to the M5 and M42 and the Motorway Network. Neighbouring occupiers include Nutter's fastenings, Edmundson Electrical & Euro Car Parts.



Description:

The property comprises a detached unit of steel portal frame construction with a mix of profile metal clad and brick masonry elevations.

The unit is refurbished comprising of newly painted concrete floors, new LED lighting, W/C accommodation and kitchenette, fitted office space, minimum working height of 5.9m to the eaves. The unit also has a single electric roller shutter and demised car parking.
