

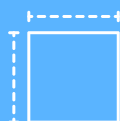

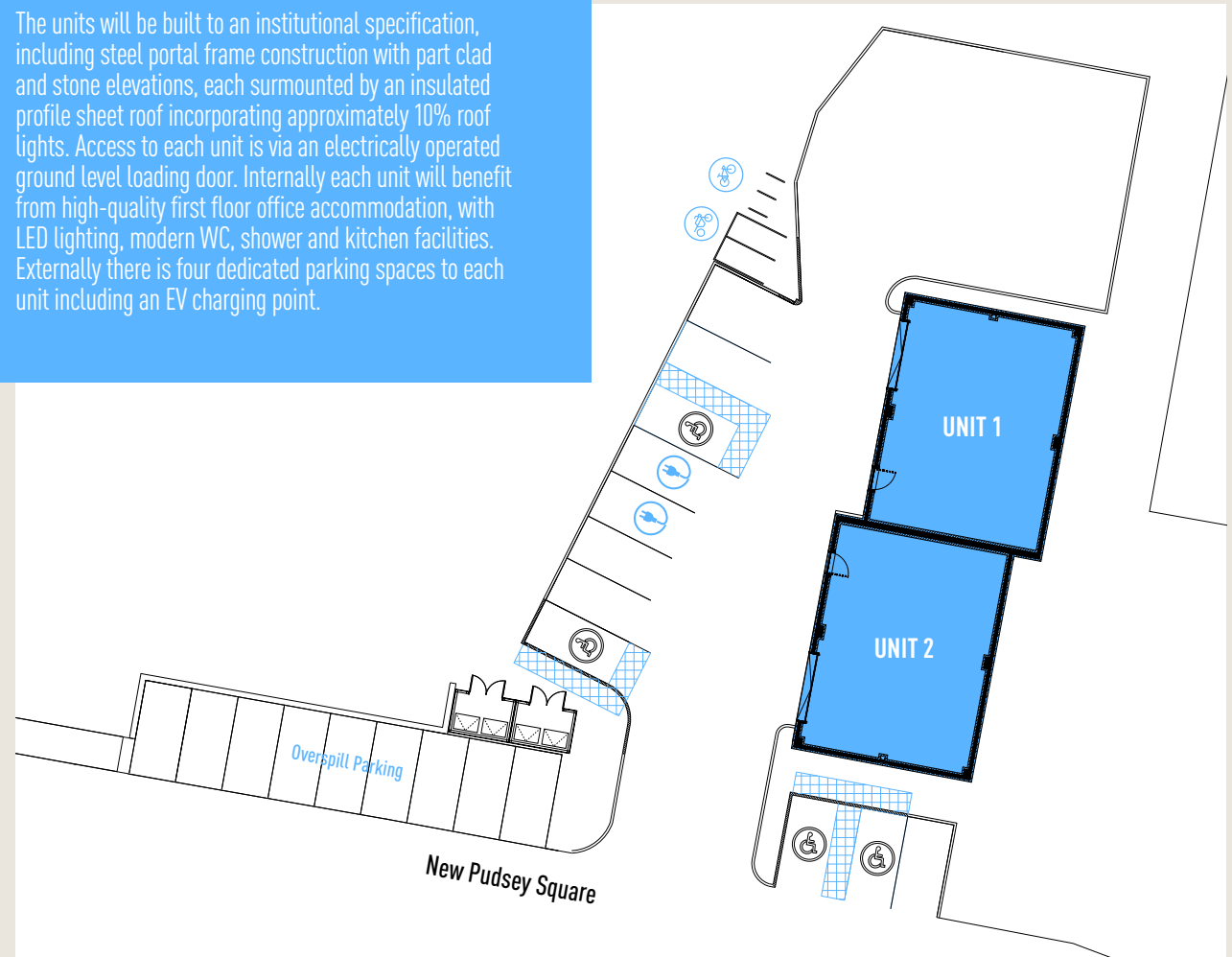

THE SCHEME WILL COMPRISE TWO BRAND NEW LIGHT INDUSTRIAL / WAREHOUSE UNITS, EACH BENEFITTING FROM FULLY FITTED OFFICE ACCOMMODATION AND WC FACILITIES.

The units will be built to an institutional specification, including steel portal frame construction with part clad and stone elevations, each surmounted by an insulated profile sheet roof incorporating approximately 10% roof lights. Access to each unit is via an electrically operated ground level loading door. Internally each unit will benefit from high-quality first floor office accommodation, with LED lighting, modern WC, shower and kitchen facilities. Externally there is four dedicated parking spaces to each unit including an EV charging point.
