DESCRIPTION

Mode 18 is a 50 acre development site ideally located at J3 M18. Following the successful letting to Amazon, 25 acres remain available for development. Allocated for employment use in the Local Plan, outline planning permission is in place for B1, B2 and B8 units with unrestricted height. Occupiers requirements can be delivered within 15 months from agreement of terms. Land is also available to let or for sale. A new access road will directly link the site to the Great Yorkshire Way and the M18 J3. A new drivethru restaurant and garage are planned. Intermodal rail facilities are just a 5 minute HGV drive away at iPort, while Doncaster Sheffield Airport is less than 10 minutes away.
