Trawden is a pleasant village location within the popular area of Pendle in Lancashire. It is located approximately 2.5 miles south east of Colne town centre and all its amenities, and within 10 minutes' drive of the M65 motorway network which links to Burnley, Blackburn and the wider motorway network.

The site is parallel to Skipton Road (B6250) which is the main arterial route through Trawden and can be accessed from Dean Street.

DESCRIPTION

The site extends to approximately 1.5 acres (0.61 hectares) and is largely rectangular in shape.

It is a sloping site to the east containing vacant garages and has a single access point at Dean Street. The immediate vicinity is largely residential and is a sought after location within the Pendle Borough.
